Extension CIP Application – 124-126 Main Street South, Alexandria iii.

THAT the Arts, Culture and Heritage Committee recommends that Council repeals Resolution No. 3, adopted on November 12, 2019, approving the Community Improvement Plan Project at 124-126 Main Street South in Alexandria Ontario as submitted by the applicants Kevin van den Oetelaar and Steven van den Oetelaar, and;

THAT the Arts, Culture and Heritage Committee recommends that Council authorizes the transfer of the total grant amount of \$5,067.05 allocated to this project to the 2021 CIP Budget for traceability and in order to be reallocated to the working reserves at the end of the year.

Staff will arrange to meet with the present property owner to show them photographs of the original details around the porch and to encourage them to restore these features through the Community Improvement Plan program.

i. Discussion CIP Application – 9 Gernish, Alexandria

Staff brought forward a possible application from the property owner located at 9 Gernish in Alexandria. Staff considers the proposed changes by the parent of the property owner as lifecycle replacements and that the CIP's use is for restoration of historical figures.

The Committee suggests forwarding a historical listing form to the property owner(s) instead of the parent in order for it to be completed with a clear statement that this does not in any way entitle the property owner to funds under the CIP.

b. Blue Plaque Program

Mr. Dane Lanken indicated that he was successful in contacting the property owners on the two buildings on St. Georges Street East to advise that the plaques are ready for installation. Both property owners have indicated the locations for the installation of the plaques. Staff is now coordinating the installation with the company through which the plaques were ordered.

Staff will also arrange for an in-person inauguration of the plaques around July 5th with media in attendance.

c. New buildings with backs facing street fronts.

Mr. Dane Lanken remarked that it is unfortunate that there are new buildings whose backs face street fronts instead of having their front doors face street fronts. This is especially upsetting given the mandate and work that is done by the Arts, Culture and Heritage Committee to preserve the heritage features of properties in the municipality. The Committee discussed how to best approach this subject with the conclusion that the members of council that sit on the Committee are best placed to discuss this issue with the Planning Department.
