



- Option 1 – St. Finnan

- Already used as a quasi dog park – Déjà utilisé comme un parc
- Already has 3 sides that are fenced – Déjà 3 côtés clôturés
- Centrally located/easy access – Lieu central/accès facile
- Grass and trees for shade – Herbe et arbres pour de l'ombre
- Existing parking spaces – Places de stationnement existantes
- Limited number of neighbours – Peu de voisins
- Good size lot – Bonne grandeur de terrain

- Option 2 – MacDonald Boulevard
 - Land located at the end of the Boulevard – Au bout du blvd
 - Very limited number of neighbours – Très peu de voisins

Benefits/Bénéfices

- There is a high number of dogs in Alexandria. Many households could benefit from this kind of park – Grand nombre de chiens à Alexandria donc plusieurs maisonnées en profiterait;
- This would fulfill a need – Répondrait à un besoin;
- Public dog parks allow dogs to get ample off-leash exercise and social activity with other dogs. When dogs get the adequate physical and mental exercise they need, humans are able to notice a decrease in the level of troublesome behavior from their dogs which will benefit society as well - Les parcs canins publics permettent aux chiens de faire de nombreux exercices sans laisse et d'avoir des activités sociales avec d'autres chiens. Lorsque les chiens obtiennent l'exercice physique et mental adéquat dont ils ont besoin, les humains peuvent remarquer une diminution du niveau de comportement gênant de leurs chiens, ce qui profitera également à la société;
- More dogs vaccinated – Plus de chiens vaccinés;
- More dogs with tags/increased source of revenue for Township – Plus de chiens avec médaillons/source accrue de revenus pour la municipalité;
- Good opportunity for residents of Alexandria to socialize with other residents/Community builder – Bonne occasion pour socialiser entre résidents/Bon pour la communauté;
- It provides a safe accessible place for older people, people with disabilities, and people who live in apartments or small spaces to care for their dogs - Il offre un endroit sûr et accessible aux personnes âgées, aux personnes handicapées et aux personnes qui vivent dans des appartements ou de petits espaces pour prendre soin de leurs chiens;

Benefits/Bénéfices

- Good opportunity for the Township to show they are committed to their residents' needs – Bonne occasion pour la municipalité de montrer qu'elle est engagée envers les besoins de ses résidents;
- It also improves enforcement of dog bylaws, ensures sensitive environments are protected from dogs and other park spaces remain free of dogs - Il améliore également l'application des règlements sur les chiens, garantit que les environnements sensibles sont protégés des chiens et que les autres espaces du parc restent exempts de chiens;
- Promote responsible dog ownership - Promouvoir la possession responsable de chien;
- Healthy environment to get people active – Environnement sain pour l'activité physique;
- A bonus feature for people looking at moving in the area and it builds a dog-friendly network for new homebuyers – Un attrait pour les personnes souhaitant déménager dans la région et il crée un réseau pour les nouveaux acheteurs de maison;
- Dog parks can also provide a focal point for community education - Les parcs à chiens peuvent également constituer un point focal pour l'éducation communautaire;
- Can provide a necessary service for the travelling community so, good for local tourism – Peut fournir un service nécessaire à la communauté des voyageurs donc un plus pour le tourisme local.

Members/Membres:

- Residents of the community of Alexandria and surrounding areas – Résident(e)s de la communauté d’Alexandria et des environs

Responsibilities/Responsabilités:

- Make recommendations to the Township concerning park design/construction – Faire des recommandations à la municipalité par rapport au design/construction du parc;
- Help establish policies and procedures of the dog park – Aider à établir des politiques et procédures pour le parc canin;
- Fundraise to help with expenses (activities, sponsorships, fence ad banners etc) – Collecter des fonds pour aider avec les dépenses (activités, parrainages, bannières publicitaires sur clôtures etc)

Park operation/Fonctionnement du parc

Township/Municipalité:

- Permits, tender or purchase processes – Permits, processus d'appel d'offres ou achats;
- Any construction or installation required – Toute construction ou installation requise;
- Lawn mowing/snow removal – Tonte de gazon/déneigement;
- Garbage collection – Collecte des ordures;
- Parking upkeep – Entretien du stationnement;
- Follow-up on complaints – Suivi des plaintes;



Group of volunteers:

- Ensuring park rules are respected and making its promotion – Veiller au respect des règles du parc et en faire la promotion;
- Organize events such as obedience classes, fundraising etc – Organiser des événements tel que des classes d'obéissance, collectes de fonds etc;
- Organize the park name contest – Organiser un concours pour trouver le nom du parc;
- Lobby for bag dispenser – Trouver un distributeur de sacs

Visibility/Visibilité:

- Add park details to Township web platforms – Ajouter les détails du parc canin aux plateformes web de la municipalité;
- Install a large sign at entrance with dog park name, rules and Township contact information – Installer un grand panneau à l'entrée avec le nom du parc, les règles et les coordonnées de la municipalité.

Things to consider/À considérer

- Grass surface only, no gravel as it is hard on paws – Surface d’herbe seulement, pas de gravier car il blesse les pattes;
- Park should be divided into three sections: a) entrance area with double doors for tractor access b) smaller dog area and c) larger dog area - Le parc devrait être divisé en trois sections : a) entrée avec portes doubles pour tracteurs b) la zone des petits chiens et c) la zone des grands chiens;
- 1-5 acres – large enough for the park to not become overcrowded and small enough to keep the park well-controlled - 1 à 5 acres – assez grand pour que le parc ne devienne pas surpeuplé et assez petit pour garder le parc bien contrôlé;
- 5-6 foot fencing – important to make the fencing high enough to keep dogs from jumping over - Clôture de 5 à 6 pieds – il est important que la clôture soit suffisamment haute pour empêcher les chiens de sauter par-dessus;
- Benches and picnic tables for humans – Bancs et tables de pique-nique pour les humains;
- Numerous garbage containers to promote cleanliness – Plusieurs poubelles pour promouvoir la propreté;
- Lighting for safety – Éclairage pour la sécurité;
- Trees for shade – Arbres pour de l’ombre.

Ex 1: Town of Hawkesbury/Ville de Hawkesbury

- Park was constructed in 2013, town provided the land, is 30,000 square feet. Park is open from 6:00am to 8:00pm (or ½ hour after dusk) all year long. Volunteers fundraised by lobbying local businesses for donations and public appeal - Le parc a été construit en 2013, la ville a fourni le terrain, est de 30 000 pieds carrés. Il est ouvert de 6h00 à 20h00 ½ heure après le crépuscule). Des bénévoles ont collecté des fonds en faisant pression sur les entreprises locales pour obtenir des dons et un appel public.
- They added agility equipment and ramps, a rain barrel and also made the park wheelchair accessible - Ils ont ajouté des équipements d'agilité et des rampes, un baril d'eau de pluie et ont également rendu le parc accessible pour les fauteuils roulants.
- Dog owners use the park at different times and sometimes multiple times a day. There is an average of 50 dogs a day with 25-35 large dogs a day - Les propriétaires de chiens utilisent le parc à des moments différents et parfois plusieurs fois par jour. Il y a en moyenne 50 chiens par jour avec 25 à 35 gros chiens par jour.

Hawkesbury Dog Park rules – Règles pour le parc canin d’Hawkesbury

Off-Leash Dog Park Regulations and Town of Hawkesbury By-Law N° 3-2014
Reviewed and Amended June 2019

Off-Leash Dog Park Regulations as posted on the dog park entrance fence.

2.1. Dogs Off-Leash Areas are hereby established on those lands as outlined in Schedule "A" of this by-law. [Cyr-de-Lasalle park (east side only).

1. Opening Hours: 7 a.m. to 8 p.m. (or one half hour after dusk).

2.4. No Owner shall remain in a Dogs Off-Leash Area between the hours of 8:00 p.m. and 7:00 a.m.

2. Owners are liable for all actions of their dogs.

"Owner" shall include any person who owns, keeps, possesses, harbours, or acts as a guardian of a dog for any length of time, whether or not that person has a licence for the dog, and where the owner is a minor, the person responsible for the custody of the minor.

3. Aggressive dogs are not permitted in the park. Owners will be prosecuted and are liable for all damages and injuries subject to the Dog Owners' Liability Act.

2.3 No Owner, whose dog is required to be muzzled including pit bulls as defined in the Dog Owners' Liability Act, or is deemed dangerous as defined in By-law N° 63-90 to provide for the regulation of the keeping of vicious dog, as amended, shall bring this dog in any Dogs Off-Leash Area.

By-law N 63-90 (1990) Regulation for keeping a vicious dog

I. Vicious dog means:

i. Vicious dog any dog with a known propensity, tendency, or disposition to attack without provocation other domestic animals, or

ii. any dog that has bitten a domestic animal or person without provocation.

Bad behaviour is a risk to both dogs and humans. Aggressive behaving dogs should not enter the park.

It is advisable for each owner to have read the Dog Owner's Liability Act (DOLA). It can be found on the Internet.

4. Dogs must have a valid licence from the Town of Hawkesbury.

2.2. Subject to Subsection 2.3, a dog Owner may permit his or her dog licensed under By-law N° 73-2002 to regulate, license and control dogs in the Town of Hawkesbury, as amended, or any successor by-law thereto, to run at large in a Dogs Off-Leash Area.

5. Dogs must be leashed before entering and leaving the park.

2.5. No Owner shall fail to keep his or her dog leashed when entering and leaving the Dogs Off-Leash

Area.

6. Female dogs "in heat" and puppies under four (4) months old are not allowed in the park.

2.10. No Owner shall permit a dog within a Dogs Off-Leash Area that is in heat or that is under four months old.

7. Dogs must never be left unsupervised by their owners.

2.7. No Owner shall fail to supervise and be within sight of his or her dog at any time.

You are responsible for your dog therefore you must be present to supervise. If being distracted by your cell phone or tablet can mean distraction from supervising your dog.

8. Maximum of two dogs per owner.

2.6. No Owner shall bring more than two (2) dogs in a Dogs Off-Leash Area at any time.

9. Pick up and dispose any dog droppings and fill any holes it may dig.

2.8 No Owner shall fail to pick up and dispose of his or her dog's feces.

2.9. No Owner shall fail to fill any holes his or her dog has dug.

10. Children under 12 years of age must be accompanied by an adult.

Children are busy being children and can be easily run into by playing dogs, or even considered as part of the game.

11. Consumption of food for both dogs and owners is prohibited inside the park.

2.11. No Owner shall eat within or give food to any dogs within a Dogs Off-Leash Area.

Etiquette

Water: Bring water, the park does not have water.

Dog Waste: Grab or bring bags for scooping poop. There are garbage cans inside and outside of the park to dispose of the waste.

Dog Collar: A regular flat collar is recommended. No chain (choke) collars, nor spike collars are allowed in the dog park. A flat collar can be easily used to grab your dog /deescalating over excited dogs. But never grab a collar to break up a dog fight! .

Hawkesbury Dog Park rules – Règles pour le parc canin d'Hawkesbury

<p>A dog harness :</p>	<p>They can be used to deescalate excited dogs. Please closely supervise your dog if wearing a harness other dogs in a fight can get tangled in the harness causing further injuries.</p>
<p>Arriving at the Park – approach park with your dog leashed. If there are 15 or more dogs in the park consider coming back at another time!</p>	<p>Your dog will be excited, but it is important that its not over excited. The dog park should not be the only form of exercise for your dog.</p>
<p>Removing the leash before entering the off leash area.</p>	<p>Dogs who are leashed and encounter dogs who are not, can feel vulnerable and anxious, increasing the risk of negative behaviours from the dogs in the park.</p>

Owners of the dogs inside the park should recall their dogs or remove them from the gate area. Thus allowing the new dog to enter without being surrounded and anxious. Dogs don't like a group of dogs rushing up to it.

<p>First visit and nervous dog.</p>	<p>Use the small dog park to allow your dog a chance to see the other dogs and smell the gang.</p>
<p>Toys at the park: Never bring the dog's favourite toy.</p>	<p>Some dogs are ball or toy obsessive, which may lead to aggressive behaviours, when other dogs want to join in or steal the toy. STAY ALERT – Recall your dog.</p>
<p>Dog Park Socializing:</p>	<p>While many owners at dog parks socialize as much as their dogs, it's important that playing dogs are monitored closely at all times for their own safety. You are there for your dog's well being. Move or walk around so that your dog looks for you and is not interested only in other dogs. STAY CLOSE, STAY ALERT.</p>
<p>Children in the dog park:</p>	<p>if you bring children with you, please supervise them at all times. Dogs playing can easily inadvertently knock a child down. Not all dogs are familiar with small children.</p>

KNOW WHEN TO LEAVE.

If your dog is being too aggressive (teeth bared, growling, biting, eyes narrowed),
Remove it from the park immediately.
If your dog is frightened with tail between its legs and trying to hide between yours,
Remove it from the park - it's not ready yet for a group of dogs.
If your dog is constantly barking at other dogs and wont stop – Remove it from the park.

Common Dog Behaviour

When dogs GREET each other.

When your dog is greeting another dog be aware of both of their demeanours.

*Friendly postures generally involve the dog making themselves «smaller» relative to the other dog.

*Not so friendly greetings involve the dog making themselves appear larger. For example:

Erect stance, head up, ears forward, tail up (possibly flicking tip), stripping (hair up on neck/back, puffed tail hair), direct stare (pupils may or may not be dilated), raised lips, low tone growl, snapping.

Appropriate owner response: Stop the behaviour immediately by Recall or remove of your dog from the other dog.

When dogs HUMP each other

Humping occurs for different reasons, including anxiety and stress.

Appropriate owner response: Recall or remove your dog from the other dog

Good game/play.

Good play is balanced and a two-way interaction; there is a change of roles.

What to watch for: The game can become intense and one of the dogs may become hyper-stimulated.

Appropriate owner response: The game should be interrupted frequently to avoid this rise of excitation.

Recall.

Hawkesbury Dog Park rules – Règles pour le parc canin d’Hawkesbury

Chasing/chase games.	<p>Good play: Its a game – but you must still observe:</p> <ol style="list-style-type: none"> 1.The pursuit must be initiated by the one who flees (invitation: «run after me»). 2.The one who pursues has his ears backwards; the one who flees has a mid to high tail. <p>Occasional change of roles excellent. No physical contact or some contact without too much impact (bumping).</p> <p>Appropriate owner response: Stay vigilant and alert, watch for increase in intensity or physical contact. Recall dog as appropriate.</p>	<p>Harassment</p> <p>A type of targeting; defined as a dog that constantly harasses a weaker, younger or smaller dog.</p>	<p>It's violent and it's an assault.</p> <p>Appropriate owner response: Immediately intervene and separate these dogs.</p> <p>Never let your dog harass another who is afraid of him/her! If it persists leave the park.</p>
Risky chase.	<p>High risk play with elevated potential for increased intensity or ganging up scenarios, see description below. What to watch for:</p> <ol style="list-style-type: none"> 1.The one who pursues (pursuer) has his ears forward and his mouth open. 2.The one who flees (pursued) has a low tail and ears. 3.There are too many bodily impacts. 4.The pursuer is aiming at the neck. 5.The pursued faces the other when they stop; the pursued can not turn its back on the pursuer. <p>Appropriate owner response: STAY CLOSE, STAY ALERT. Recall your dog immediately to reduce the risk.</p>	<p>Rejection When one or more dogs reject another. The victim is under intense stress!</p>	<p>Appropriate owner response:</p> <p>Owner of victim – remove your dog!</p> <p>Other owners, Recall your dogs.</p> <p>If your dog is often a victim, the dog park is not for him/her.</p>
<p>“Ganging UP”</p> <p>An archaic instinct of predatory behaviour in which dogs will run and catch prey (but do not kill and do not eat).</p>	<p>What to watch for in the victim: The «victims» do not have a precise portrait and many become reactive, snapping at the predator or running away from approaching dogs.</p> <p>Appropriate owner response: Recall your dog – STOP the behaviour.</p>	<p>How to break up a FIGHT:</p>	<p>Appropriate owner response:</p> <p>Do not panic or scream! This will escalate the dogs' energies!</p> <p>Never try to pull your dog off by their collar. The chances of getting bit are very high.</p> <p>Try to grab the dog by their hind legs or, even better grab them by the hip/waist. You can really dig into his/her fur and skin and pull him/her off. The typical reaction for a dog is to look back and to see what grabbed them.</p> <p>If you think the situation is too dangerous let other people handle it!</p>
<p>“Targeting” One dog follows another dog without rest, no matter what signals the victim sends.</p>	<p>What to watch for: The targeting dog has ears and tail straight, eyes - head - column aligned in the orientation of the targeted dog. Targeting can turn into sexual harassment.</p> <p>Appropriate owner response: Recall your dog – STOP the behaviour</p>

Ex 2: Township of Russell dog park – Parc canin de la municipalité de Russell

- Located at 550 Notre Dame Street, the Township of Russell operates a well-fenced **2.2 acres** dog park, open all year round from 05h00 until 23h00. There are benches for humans. As yet, there is little shade but there is a small gazebo on site. The dog park opened in 2014 - Situé au 550, rue Notre-Dame, le Canton de Russell exploite un parc à chiens bien clôturé de 2,2 acres, ouvert toute l'année de 05h00 à 23h00. Le parc canin a ouvert ses portes en 2014.
- At the dog park, there is a: Gazebo with picnic tables, jumping circle, dog water fountain (turned off during the colder months) and 2.2km of open space - Au parc canin, il y a un : gazebo avec des tables de pique-nique, un cercle de saut, une fontaine d'eau pour chiens (éteinte pendant les mois les plus froids) et 2,2 km d'espace ouvert.
- Dog owners use the park at different times and sometimes multiple times a day. There is an average of 200 dogs that use the park daily - Les propriétaires de chiens utilisent le parc à des moments différents et parfois plusieurs fois par jour. Il y a en moyenne 200 chiens qui utilisent le parc par jour.

Township of Russell dog park rules – Règles pour le parc canin de la municipalité de Russell

- When entering and exiting the off-leash area, your dog needs to be leashed;
- Poop and scoop is mandatory;
- All dogs must be legally licensed, have current vaccination and must wear tags;
- Dogs under 4 months of age, female dogs in heat, sick or injured and aggressive dogs are not allowed in the dog park;
- Never leave the fenced-in area while your Dog is in the Dog Park;
- Carry a leash at all times while your dog is in the Dog Park;
- You must have verbal control of your dog at all times;
- If your dog is showing aggression, it cannot enter the park. You must immediately leash and remove your dog(s) from the park at the first sign of aggression;
- You cannot have more than two (2) dogs at the park as the owner;
- Glass containers, toys or food are not permitted in the park;
- No smoking;
- Pinch (prong), choke and spike collars are not allowed in the dog park;
- Handlers must be 15 years of age and older. Children under 14 years old must be accompanied by an adult.

Township of Russell dog park disclaimers – Clause de non-responsabilité pour le parc canin de la municipalité de Russell

- Dog owners are subject to the *Dog Owners Liability Act* and Russell Township Municipal By-law;
- Dogs must wear their dog tags to use the park.
- Owners are legally responsible for their dogs' actions;
- Public Safety and Enforcement officers will monitor the park randomly;
- The Township is not responsible for any loss, damage or injury that may occur from the use of this dog park.



Additional information/Information additionnelle

- In both locations Town By-law Officers do regular drive by and do spot checks to see if dogs have their tags - Dans les deux endroits, les agents des règlements municipaux passent régulièrement et effectuent des vérifications ponctuelles pour voir si les chiens ont leurs médaillons.
- Rules and etiquette for the dog park need to be clearly identified and visible at the dog park entrance. If there is an incident where a dog injures another dog or human, under DOLA, liability rests solely with the owner of the offending dog - Les règles et l'étiquette du parc canin doivent être clairement identifiées et visibles à l'entrée du parc canin. S'il y a un incident où un chien blesse un autre chien ou humain, la responsabilité incombe uniquement au propriétaire du chien fautif.

- If there is a case of kennel cough for example a sign is put up to warn dog owners and they decide if they bring their dog inside the park or not. Always the owner's responsibility. Same with sharing a common water source - S'il y a un cas de toux de chenil par exemple, un panneau est mis en place pour avertir les propriétaires de chiens et ils décident s'ils amènent leur chien à l'intérieur du parc ou non. La responsabilité revient toujours au propriétaire. La même chose s'applique pour le partage d'eau.

Additional information/Information additionnelle

- One of the biggest dangers of dog parks is that they often don't have separate play enclosures for large and small dogs. Even without meaning to, a large dog can easily cause serious injury a smaller dog. So to ensure the park's success and limit incidences different zones need to be included in the park's design - L'un des plus grands dangers des parcs pour chiens est qu'ils n'ont souvent pas d'enclos de jeu séparés pour les grands et les petits chiens. Même sans le vouloir, un gros chien peut facilement blesser gravement un petit chien. Ainsi, pour assurer le succès du parc et limiter les incidences, différentes zones doivent être incluses dans la conception du parc
