RE: Public Works Work Plan Update October 2021

Background / Analysis:

Solid Waste Management

Landfill

The landfill contractor has resigned as of early October and as such, the Township is currently reviewing the submissions for a new contractor. Please note that the landfill winter hours (Wednesday and Saturday 8am to 4pm) are in effect as of October 16th.

RARE

The Township auditor is in the process of auditing RARE in the month of October.

The operational review of RARE is in draft form and will be presented to council in the fall of 2021.

Transportation Services

Fleet

The automatic vehicle location (AVL)/geographical positioning system (GPS) transition from ACE to Geotab is underway and will be fully functional in the fall of 2021 pending DiCan's schedule.

Road Maintenance

Pothole patching, grading and general road maintenance is ongoing.

Concession 12 IL is prepared for paving and pending the contractor's schedule and staff are hopeful this will be underway the first week of November at the latest.

Roads Needs Study

The report has gone back to the consultant for additional work and will be presented to council on November 8, 2021.

Creek Road Bridge

The project was completed at the end of August and the ribbon cutting was Tuesday October 19th.

Loch Garry Dam

Spillway replacement is underway with work being done by staff and should be completed by the end of October. This project is being done in collaboration with the Raisin River Conservation Authority.

Sidewalks

Sidewalk deficiencies have been marked and minor repairs scheduled pending resource availability. Staff are developing a five-year replacement program.

Pavement Markings

Symbols, parking stalls, cross walks, accessibility markings and stop bars are 80% complete.

Sign Inventory and Retro-reflectivity

Replacement of the failed and poor signs is still underway and will be complete before the end of the year.

Environmental Services

The team will have a vacancy after October 22nd and therefore the Water Works Operator position is currently posted and staff will be working on recruiting for a new operator in November.

Water

Maxville Water

Maxville water is at approximately 85% complete for connections and inspections.

Alexandria Water

Valve turning is complete, hydrants are winterized and fall flushing will be complete by the end of this week.

Glen Robertson

Ministry of Environment Conservation and Parks completed the annual inspection and staff are waiting for the inspection report.

Wastewater

Sludge levels will be measured in the Alexandria and Maxville lagoons in late October as per the regular monitoring done twice per year to determine sludge accumulation. Staff will then coordinate phase 2 of cell B in Alexandria sludge removal during the spring of 2022 as part of the 2022 capital works.

<u>Alexandria</u>

Relining of the trunk sewer on the Garry River is underway this week.

Stormwater/Drains

The 2021 drain maintenance permits have been applied for with the conservation authorities. The maintenance will be scheduled once the permits are received, and crops are off the fields.

There are 12 drains scheduled for maintenance in the fourth quarter of 2021:
