

**THE CORPORATION OF THE TOWNSHIP OF NORTH GLENGARRY**

**BY-LAW NO. Z-01-2022**

**BEING A BY-LAW TO AMEND ZONING BY-LAW NO. 39-2000**

**WHEREAS** By-Law No. 39-2000 regulates the use of land and erection of buildings and structures within the Township of North Glengarry, County of SD&G;

**AND WHEREAS** the Council of the Corporation of the Township of North Glengarry deems it advisable to amend By-Law 39-2000 as hereinafter set forth;

**NOW THEREFORE** the Council of the Corporation of the Township of North Glengarry enacts as follows:

1. Notwithstanding the provisions of Section 10.2 to the contrary, on the lands described as being Con 1, Part Lot 1: RP14R4150 Part 1 (3910 County Road 34, Alexandria, ON) of North Glengarry zoned Rural Industrial Special Exception 2 (MR-2) on Schedule “A” attached hereto, the following provisions shall apply:
  - i) MR-2 Special Exception: To add the use of a mini storage facility and the use of an outdoor recreational vehicle storage area.
2. That Schedule “A” of By-Law 39-2000 is hereby amended by changing the “MR” Zone Symbol on the subject lands to “MR-2” on the Schedule “A” hereto.
3. That Schedule “A” attached hereto is hereby made fully part of the By-Law.

This By-Law shall come into effect on the date of passing hereof subject to the provisions of the Planning Act.

**READ** a first, second, third time and enacted in Open Council, this 25<sup>th</sup> day of April 2022.
