
***North Glengarry Fire Department is submitting to allocate the funding to support our training program. Under the guidance and support of the Ontario Fire College, North Glengarry Fire Department will be delivering NFPA 1001 Fighter I & II, through a learning contract. As a result of COVID-19, NGFD's have moved to a blended learning model for all our 75 members through an online learning platform – Target Solutions and in-house training. The grant funds would be allocated to fund tablets and laptops to support both the new recruit – OFC learning contract and experience members, through the blended learning training sessions. By purchasing this IT equipment, it will enhance our ability to ensure our members can continue to train safely, efficiently and support our community needs. NGFD estimate the allocation of \$7000 will permit us to purchase approximately 5-6 devices. Once approved NGFD will work to secure the IT equipment immediately through local vendors to maximize the allocation to its fullest.***
